Senior Vice President Report

January 10, 2026



President Mike Monahan populated the committees in the spring and I compiled a list with contact information.

Secretary Jim Closson notified us in the summer that he was selling his house and moving to Kansas. Larry Gamble stepped into this role and has been an extremely productive member of the Excom. Thomas Blackmon resigned as Regional VP of the Pee Dee and Scott Bruton was appointed to this role. After a new slate and then some tweaking, the nominating committee (Gary Blanpied, Paul Cashion, Joe Glavitch, Thomas Blackmon, Miles Montgomery, Ted Walker, Tom Sharkey and Larry Gamble, ex officio) voted to recommend a full slate of officers for 2026 which is being presented by the nominating committee chairman Paul Cashion.

Communications. Jim Closson made many changes to help us utilize the old website and John Ethan Boyes faithfully updated the calendar of events. After several months of seeking the best solution to our communications issues we have transitioned to a new website with the same name SCSSAR.org now on rosehosting.com, with dual member Dave Desmarais as the webmaster and the opportunity to have several members assist him. Dave was very important to our communications before he moved to Missouri. John Ethan Boyes and Jim Herritage are helping and Larry Gamble is exploring ways members can play their bills other than by check, for the annual banquet and dues collection.

In June 2025, Clyde Howell and I began to update the spreadsheet system that we used under Bill Wilson for the past 2 years. On June 23, I downloaded members' info from the blue database, including dual members and the reconciliation file. Clyde went through all the 900 members, updated the sheets for each of the 24 chapter plus at large members. We repeated this action in August, as well, so we would have the most recent and up-to-date information reflected. I tried to identify whether the treasurer or another person would be the contact for each chapter and gave the list to Clyde. In the second week in September Clyde sent email to the 850 or so members who had an email address in the database and about 50 got a mailed letter with their dues bill. About 50 of the email addresses turned out to be bad so these increased the number of paper mailings to about 100. No

specific due date was given. When asked about this the response as always is that Reconciliation will begin on December 1, 2025, and dues need to be paid in advance of that date such that they can be accurately recorded on the spreadsheet. The rate of members paying across the Association remains slow with only 7 chapters showing dues collection complete as of 12/29/25; 18 chapters show remaining members unpaid. Two rounds of emails, 2 paper mailings plus follow-up phone calls and texts. On December 29 there were 795 paid (87.8%) and 108 unpaid. It is projected that the State Association overall will lose approximately 25 members due to not renewing their memberships; exact numbers remain to be determined. There are some adjustments that will need to be paid after January 1, 2026, to ensure accurate counts in each chapter (moving Life Members to the At Large Chapter, etc.).

Issues:

1. We found that there is no place where State Life Members are listed so we think that we should add an "L" to the State ID number.

2. There appears to be no place where State Emeritus Memberships are recorded. National Emeritus can be tracked in the Blue Database, but there is nothing at the State level.

3. Transfers out of state have not been routinely tracked and communicated to State. This becomes important since members who are still listed as members of SCSSAR stand to be deactivated in error or may not have the information on how to renew their memberships in the gaining states. There is a similar but lesser issue with transfers between chapters within the State.

4. We need to revisit the methods by which we contact Compatriots regarding Dues Collection. We initially used paper mail (USPS) and mass email. These were not as effective as hoped or intended. Later phone calls, individual emails, and text messages were more effective. Text was not seen as a primary channel to reach members. In each of these methods we encountered a sensitivity to spam which resulted in notices being ignored or being sent directly to SPAM/Junk folders which members do not check regularly; hence the notices were missed.

5. Numerous Compatriots asked if they could pay electronically. This capability did not exist for us but needs to be explored for future operations.

We explored venues and availability for the annual meeting and banquet

and signed a contract with the Hilton Garden Inn on Farrow Road in Columbia SC for April 17 and 18, 2026. The July BOG voted to stay there for the next 3 years and the dates are reserved. In 2028 Easter occurs on that weekend so that the dates shift to the earlier week. A committee for the banquet and annual meeting has been appointed with Clyde Howell as Chairman. Larry Gamble is leading the registration and working with John Holmberg on the printing. A flyer will be ready by January 10, 2026. We would like to start registration January 12, 2026.

A hotel link for reservations has been obtained and is being utilized.

I used the blue database to create my own email lists and sent out "save the date" on December 26, 2025.

A list of awardees for the annual banquet has been compiled and a list of needed supplies was sent to Larry Gamble who utilized the state credit card to order the list and has received the order.

Updating Blue Database: The state secretary assigns each new member who has been approved and given a national number, a state number. Jim Closson caught up a long backlog. Only the state secretary can make additions to the medals awarded record in the Blue Database. I compiled a list and populated a spread sheet of medals that had been awarded and not listed as well as mistakes that had been made in past updatesqaaa2. Most of the new ones were from the 2025 awards banquet and sent in by Joe Galvitch for his chapter. Jim Closson brought the database up to date.

The Chapter Secretary Is the Pulse of the Chapter

The Chapter secretary is the focal point of communications for the SAR. This will cover a few key tasks that keep current information available to State or National levels. These items are more than house-keeping records; they help improve the chapter's historical archive and member satisfaction with the SAR.

1. Chapter Activity Reports — these are required quarterly and this is a recap of activities like the name implies and helps maintain a consolidated chapter history.

a. When did your chapter meet, how many members attended, what was the program or guest speaker?

b. Any new members inducted?

c. Did you host any events, if so when and what were they, where were they held, event purpose, any invited dignitaries, SAR/DAR/CAR members attending.

d. Did any members attend other events SAR or DAR

e. Did the chapter present any awards, certificates or medals

2. Member Updates — at the state level we need to know about certain changes.

a. Member Transfers need to be coordinated with the State Secretary.

i. Chapter to Chapter — an email from the two chapters detailing who is moving, their National ID number, and the effective date. Include the State Secretary so it is clear both chapters agree to the transfer.

ii. Out of State — this one needs a form which the member initiates and sends to the gaining chapter who then coordinates with the demitting State Secretary to verify dues are up to date, then it's forwarded to the gaining State Secretary for sign off and

forwarding to National SAR.

iii. Death Notifications — Chapter Secretaries are in the best position to know about the passing of their members. National has put a form on the website to make the notification and they send it back to the State Secretary. This is available on the SAR.org website and it's the third item on the blue banner under drop down labeled "Quick Links."

3. Officer Change Reports — these are needed at the change of officers either with the annual chapter election or if a chapter needs to appoint someone to fill an elected position.

a. These go to the State Secretary on the "Change of Officers Reporting Form."

b. It's used to coordinate member profile data like positions held and to coordinate chapter access to member profiles.

One other area chapter secretaries can help their members is with their initial login to the SAR website. Once there, members can update their Profile's basic information like address, phone, email. This is important for keeping in touch. If needed, the Chapter Secretary has access to the database and can update information for members.

These are key roles that make sure we keep communications flowing to our members.

This is something the Chapters can accomplish on the National website at SAR.org. The last couple emails I got, the chapter didn't provide me the compatriots full name or National number.

It's much easier and timely if the Chapters accomplish this. They just go to the National site, sign in, then under the blue bar the QUICK LINKS is actually a drop down menu when you hover over it. Click on Compatriot Death Reporting and fill in the blanks of the online form. When they are done, National emails the reporting official confirmation and that email needs to be forwarded to me.

All Compatriot Grave Markings must now be reported on the attached Compatriot Grave Marking Report form. This Compatriot Grave Marking Report form can also be found in sar.org Forms and Manuals tab. The Google Compatriot Report form in the Patriot Records Committee Website is being removed and should no longer be used.

Compatriot grave marking medal form has been simplified. All Compatriot Grave Marking Medal Requests must be requested on the attached Compatriot Grave Marking Medal Request form. This form is also available in sar.org Forms and Manuals tab. The more complicated original form is still accepted.

We recommend that chapters holding a compatriot grave marking provide the member number and cemetery number in their ceremony handout. This will assist compatriots seeking a medal by having this information available when completing their medal request form.

Col. Robert Anderson Chapter: Knight Essay Contest

The George S. & Stella M. Knight Essay Contest is a national competition that invites high school students in grades 9–12 to write about the American Revolution, the Declaration of Independence, or the framing of the United States Constitution. The contest is open to all U.S. citizens and legal residents attending public, private, parochial, or home schools in grades 9–12. Students must submit an original 800 to 1,200-word essay on an event, person, philosophy, or ideal. The essay must include four parts: a title page, essay pages, a bibliography (works cited), and a contestant’s biography. Judging criteria include historical accuracy, clarity of thought, organization, grammar and spelling, and documentation.

The winner of this year’s essay contest sponsored by the Col. Robert Anderson Chapter is Elisabeth Hand, a student at Bob Jones Academy, Greenville, SC. Her essay, entitled “Principia Classica: Greco-Roman Influence on the Founding of America,” won at both the chapter and state level competitions, and has been submitted for competition at the national level.

As of last semester, Elisabeth was ranked 10th out of 99 students with a cumulative GPA of 4.8 on a weighted 5.0 scale. Complementing her writing skills and an interest in US history, her extracurricular activities include participating in a school service organization, serving as a designer on her school’s yearbook staff, and serving in leadership positions at her school. Further, she competed on her high school speech and debate team and performed in her high school symphony orchestra during her freshman year. She has taken violin lessons for eight years, of which six years she participated in school orchestras. After high school, Elisabeth plans to attend college and double-major in business and graphic design/digital illustration.


The 82nd State Conference of the South Carolina Society Children of the American Revolution

Stronger Together: How Local SAR and DAR Chapters Can Serve Community and Country Side by Side

In towns across America, two distinguished lineage societies often meet only a few miles apart—sometimes in the same historic sanctuary or civic hall—yet operate on parallel tracks. The Sons of the American Revolution (SAR) and the Daughters of the American Revolution (DAR) share common ancestry, mission, and patriotic purpose. When local chapters intentionally collaborate, they multiply their impact—not only for their members, but for the communities they serve.

At their core, both organizations exist to perpetuate the memory of the Patriots of the American Revolution, promote historic preservation, and foster education and patriotism. A natural first step toward partnership is shared programming. Rather than hosting entirely separate monthly meetings, chapters can coordinate one or two joint meetings annually featuring a compelling speaker on Revolutionary War history, genealogy, or local heritage. A well-publicized joint event draws larger audiences, introduces prospective members to both societies, and strengthens civic visibility.

Genealogical collaboration offers another rich opportunity. SAR and DAR registrars often work with overlapping families. Hosting a “Patriot Ancestor Workshop” together—perhaps at a public library—allows members of both organizations to guide guests through lineage documentation, research tools, and applica-

tion procedures. Combining expertise accelerates applicant success while demonstrating unity of purpose. For communities with strong ancestral ties, such workshops can spark renewed interest in local history.

Youth outreach is another area where cooperation shines. The DAR’s longstanding emphasis on education and youth programs complements the SAR’s essay contests, orations, and JROTC recognition initiatives. A joint awards ceremony honoring local students—complete with certificates, medals, and press coverage—amplifies the message that patriotism and scholarship matter. Shared sponsorship reduces costs and increases participation, while giving students and parents a clearer understanding of both organizations’ missions.

Historic preservation projects also benefit from combined effort. Whether restoring a neglected cemetery, cleaning Revolutionary War markers, or sponsoring a new roadside historical plaque, the manpower and fundraising capacity of two chapters can accomplish what one alone might postpone. Joint dedication ceremonies, complete with color guard participation and period attire, become meaningful community events that attract local officials and media attention.

Community service presents further opportunity. From supporting veterans’ initiatives to participating in Constitution Week observances each September, SAR and DAR chapters can coordinate calendars to avoid duplication and reinforce attendance. Appearing together in parades or civic ceremonies sends a visible signal of cooperation and shared heritage.

Communication is key. Establishing an annual leadership luncheon between chapter officers fosters goodwill and ensures calendars align. Cross-publishing highlights in each other’s newsletters broadens awareness and encourages dual membership among qualified individuals. Many families include both eligible men and women; working together makes it easier for them to see how participation in both organizations strengthens family engagement.

Ultimately, collaboration between local SAR and DAR chapters is less about efficiency and more about example. The Patriots whose sacrifices they honor did not labor alone; they relied on neighbors, families, and communities united in common cause. When today’s lineage societies follow that model—planning together, serving together, and celebrating together—they embody the very spirit they seek to preserve.

Stronger together, they honor the past while shaping a more informed and patriotic future for their communities.

Why Every Chapter Needs a Website

Leadership within the South Carolina Society, SAR has made a forward-thinking investment in the future by developing a new state website that provides member chapters with a tremendous benefit: free chapter websites with powerful capabilities. That should prompt an important question — why does a chapter need a website in the first place? At least five strong reasons come to mind.

First, outreach. A chapter website serves as the front door for men who are curious about their Patriot ancestors and the work of the Sons of the American Revolution. Many prospective members begin their journey online. A well-designed site offers them a local connection, an overview of the lineage research process, and a clear path forward. It can explain what documentation is required and, just as importantly, connect them with knowledgeable leaders such as our Registrar Mike Gillis who can guide them through mapping and proving their descent.

Second, member reference. For existing compatriots, a website becomes a living handbook. Instead of searching through old emails or paper files, members can quickly find chapter leadership contacts, committee descriptions, chapter history, genealogical resources, and essential SAR knowledge. It is a central, always-available knowledge base that strengthens participation and understanding.

Third, a reliable calendar. This is where the state society plays a pivotal role. It makes little sense for each chapter to independently track dozens of events across South Carolina. Positioned at the center of statewide activity, the state society is best equipped to publish and maintain an official calendar. Chapter websites, in turn, can share that trusted information with their members, ensuring better attendance and coordination.

Fourth, preservation of archives. Too often, valuable records vanish when officers change, files are misplaced, or longtime record keepers pass away. A chapter website can serve as a stable digital repository for bylaws, meeting minutes, annual reports, and other key documents. It quietly tells future members, “We were here, and we took our responsibilities seriously.”

Fifth, an ongoing meeting place. Today’s communication tools allow boards and committees to meet virtually and exchange ideas easily. A website provides the hub — linking members to virtual meeting spaces, shared documents, and discussion points. It extends the chapter beyond a once-a-month gathering into a continuous, collaborative community.

In short, a chapter website is not a luxury. It is an essential tool for outreach, education, coordination, preservation, and connection — all vital to our mission.

Let Me Tell You About My Patriot Ancestor

Michael Watson was born in Virginia on 10 April 1726 to William and Penelope Watson. Around 1745, his parents moved to South Carolina. William, along with his brother John, settled in the Ridge Spring area on land granted by Kings George II and George III.

The Watson family was ever ready to “buckle on their swords” at the first call to arms. The following is a brief sketch of one who ultimately gave his life in the cause of American liberty. Michael, the fifth great-grandfather of Norman Smith, married Martha Watson, daughter of his uncle John Watson. He was a prosperous and industrious planter. Michael and Martha had five children, including Keziah Watson. Keziah married Robert Willis, and they moved to present-day Barnwell County, where they established a plantation called Wildwood. The nearby town of Williston is said to have been named for Robert Willis.

Michael first saw military service during the Cherokee Expedition under Colonel Grant in 1762. He again fought against the Cherokee in 1766, serving as a captain. He rendered especially effective service at Little River, where the Indians were repulsed and the division saved—an outcome largely credited to Watson’s leadership. After the action, numerous bullet holes were found in his clothing, through which musket balls had passed without wounding him.

In 1767 and 1768, he played an active role in suppressing lawlessness in the region as a Regulator. In 1767, he, along with his father, his brother William, and two others, captured and killed a band of outlaws. Tragically, his father and brother were themselves killed in the conflict.

As tensions with Great Britain grew, Watson united with the Whigs for mutual defense and was chosen as a leader. In doing so, he drew the vengeance of British authorities but rose high in the confidence of leading Patriot officers. His home, located on the road from Charleston to Cambridge, was exposed to frequent hos-




tile visits by the British and their Tory allies. His energy, courage, and the large number of active Whigs under his command made him an object of hatred. Tories surrounded his home several times in attempts to kill him, and his property was burned four times—his dwellings, mills, barns, cribs, and nearly everything he owned.

In May 1782, Captain Watson learned of a band of Tories in Dean’s Swamp, near the present town of Springfield in Orangeburg County, and resolved to attack them. As Watson’s men approached, two Tories were seen attempting to hide. Captain Watson, Lieutenant William Butler, Sergeant Thomas Vardell, and others rode forward to capture them. Watson quickly realized they were decoys and warned his men that the main body of Tories lay concealed in the brush. The Tories rose and delivered a well-aimed volley that brought down Captain Watson and several of the leading Whigs. Watson survived long enough to be carried to Orangeburg, where he died on 24 May 1782 and was buried with military honors.

Martha Watson’s Service

During the war, Martha Watson rode throughout the backcountry carrying messages and securing supplies for her husband, Captain Watson. After the war, she married Jacob Odom.

In 1791, during President George Washington’s tour of the Southern states, he traveled from Augusta, Georgia, to Columbia, South Carolina, and dined at the home of Jacob and Martha Odom near present day Monetta. Washington presented Captain Michael Watson’s daughter Mary with a beautiful jewel box, which remains a treasured heirloom among her descendants.

New Educational Play for Grades 3–5

As America 250 approaches, our society continues its mission to help young Americans discover the courage, challenges, and everyday realities of those who lived during our nation's founding. In support of this effort, I am pleased to announce the release of a new original play created specifically for students in grades 3–5.

Introducing The McElroys of Camden

Set just outside Camden, South Carolina, in late 1780, the play follows the fictional McElroy family as the turbulence of the Southern Campaign presses in around them. Although the family is fictional, the situations they face reflect the real experiences of countless backcountry families whose lives were upended by the events surrounding the Battle of Camden.

The play uses an “Our Town” storytelling approach, with a narrator who introduces each of the six scenes and offers a closing reflection—helping younger audiences stay grounded while drawing them into the life of a Revolutionary War-era family.

Engaging, Accessible, and Classroom Friendly

The cast includes:

- Narrator
- Five main characters from the McElroy family
- One cameo appearance by a wounded Patriot soldier

To accommodate difference performance needs, this play may be produced as a Reader's Theater or as a full play with staging, costumes, and movement.

To support simple, visually rich classroom productions, scene-specific background images are included. These can be projected or displayed behind the actors to help students better visualize the setting and historical context of each scene.

Support for Teachers and Historical Context

Recognizing that not all teachers are familiar with the Kershaw District as it existed in 1780, the play package includes basic historical information to help educators understand:

- A map of the Kershaw District during the Revolutionary War

- Background information on the British Occupation of Camden

- Key military activity and events leading up to the Battle of Camden

This background material equips teachers with the context they need to guide students confidently through the story and post play discussions.

Built In Discussion Prompts

Each scene includes:

- Reflection questions
- Prompts for critical thinking
- Suggestions for connecting historical events to students' own lives

Teachers can use these prompts immediately after each scene or as part of a culminating activity, enabling students to explore not just what happened—but how it might have felt for a family living through the Southern Campaign.

A Free Resource for America 250 Programming

This play is available free of charge to any school, educator, or organization seeking to encourage America 250 learning among youth. Its small cast, minimal staging requirements, and age-appropriate storytelling make it ideal for classrooms, assemblies, or community programs.

Narrator's Opening Monologue
 (Center stage, spotlight on narrator)

It's the summer of 1780. Camden, South Carolina—a town caught in the tightening storm of the Revolutionary War. The British have taken the town, beginning their occupation in June. Redcoats patrol the streets, and Lord Cornwallis himself has claimed the home of Joseph Kershaw, turning the grand house into his headquarters and a symbol of British control.

(Introduction of the family – important for cast members to acknowledge their part as introduced by the Narrator if being performed as a Reader's Theater production)

Just beyond Camden's northern edge lives a family feeling the weight of this new reality. Samuel—the father, a farmer and militia courier, moving quietly between danger and duty. Eliza—his wife, tending the home and livestock, keeping life steady while the world shifts around them. Their children: Mary, seventeen—spirited and sharp, always listening for the whispers of news. Anne, thirteen—quiet, thoughtful, learning to sew, care, and watch. And Thomas, only seven—wide-eyed, witnessing his world change in ways he cannot yet understand.

Through their voices, we will walk the dusty roads of rumor, fear, and resilience.

(Narrator steps aside. Lights rise on Scene 1.)

Scene 1 – Rumors of Trouble

Setting: Kitchen of the log home.

Props: Wooden table with bread loaf, clay jug, tin cups;

Narrator's Opening Monologue Background



Scene 1 Background



spinning wheel; mending basket; lantern; wooden toy horse.

Mood: Uneasy calm—normal life shadowed by whispers of war.

Stage Directions:

- Samuel enters from stage-left, hat in hand, boots dusty.
- Eliza sits at table, mending shirt.
- Mary leans against table, alert.
- Anne sits near hearth, fiddling with thread.
- Thomas plays on floor with toy horse.

Narrator:

Early July. Rumors ride faster than wagons. Fear begins to settle like dust.

Dialogue & Interaction

Samuel (pacing):

The mill was buzzing with talk today—British patrols near the Wateree. If they're scouting, Camden won't stay quiet for long.

Eliza (pausing, voice tight):

Patrols? Lord help us... if they take the cattle, what will we feed the children come winter?

Mary (leaning forward):

Neighbors say they saw redcoats on the river road. They're closer than anyone thought.

Anne (softly):

Why are folks whispering about leaving? Where would we even go?

Thomas (looking up):

Mama, why do soldiers take food? Don't they have their own?

Samuel (kneels by Thomas):

Armies eat more than they carry, son. They take what they need—and what we need too.

Eliza (sets down mending, folds hands):

If they come here, we'll have nothing left. Nothing.

Mary (moves closer to Anne):

Don't listen to the talk of fleeing. We'll manage. We always do.

Anne (looks up towards Mary):

But what if they burn the farms like they did near the river? What then?

Samuel (turns sharply towards the girls):

Who told you that?

Scene 2 Background



Anne:

Mrs. Carter said her cousin's place was ash. She said the British did it to scare folks.

Eliza (rises, voice firm):

Enough of that talk. We'll stay put. This is our home.

Mary (challenges gently):

But Mama, what if staying means losing everything? Shouldn't we have a plan?

Samuel (gruff tone):

Our plan is to keep our heads down and our faith strong. Camden's not lost yet.

Thomas (holds toy horse tight to his chest):

I don't want them to take our cow.

Eliza (kneels to Thomas):

No one's taking her, sweetheart. Papa will see to that.

(Lights dim as narrator steps forward.)

Narrator:

These whispers are the first ripples of a storm. For Samuel and Eliza, every choice will weigh heavy. For Mary and Anne, every rumor will shape their courage. And for Thomas... every question will echo louder than the cannons to come.

● Scene 2 – Livestock Raids

Setting: Front porch of the log home.

Props: Wooden bucket, rope, sack of grain, lantern, small stool.

Mood: Tense, defensive—survival feels fragile.

Narrator:

Mid-July. Raids begin. British detachments seize cattle for the Camden garrison. For families like Samuel's, every hoof-print matters.

Stage Directions

● Samuel enters from stage-left, sweaty, rope in hand, boots muddy.

● Eliza sits on the porch step, counting coins nervously.

● Mary leans against the porch rail, arms crossed, watching the road.

● Anne sits on a stool, sewing slowly, head down.

● Thomas holds a wooden toy cow, sitting near Eliza.

Dialogue & Interaction

Samuel (urgent, breathless):

I've hidden the cow deep in the swamp. If they find her, we'll have nothing.

Eliza (voice tight, counting coins):

I traded for flour and salt, but it cost near everything. How long can we keep this up?

Mary (angry, pacing):

Sarah, our neighbor down the road, her horses are gone. She cried so hard... I told her we'd manage somehow, but what if we're next?

Anne (softly, stitching):

Mama, the thread's almost gone. What happens when we can't mend clothes anymore?

Thomas (hugging toy cow):

Will our cow come back, Papa? I miss her.

Samuel (drops rope, wipes brow):

I'll check her at dawn. If they track me, we'll lose her—and maybe more.

Eliza (rises, voice trembling):

Samuel, what if they come tonight? What if they search every farm?

Mary (steps forward):

We can't just wait for them to take everything. Why don't we fight back?

Samuel (turns sharply towards Mary):

Fight back? With what? A pitchfork against muskets?

Anne (whispers):

Mrs. Carter said the British took her cousin's chickens too. They're taking everything.

Eliza (kneels to Thomas):

Sweetheart, Papa will keep her safe. You trust him, don't you?

Thomas (nods slowly, holding the toy cow tighter).

(Lights dim as narrator steps forward.)

Narrator:

For Samuel, every hiding place is a gamble. For Eliza, every coin feels heavier than gold. And for the children—every loss chips away at the world they knew.

● Scene 3 – The Smell of Smoke

Setting: Outside near a tree, lantern light.

Props: Lantern, blanket for Thomas, wooden bench.

Mood: Fearful, somber—war feels close.

Narrator:

July 30. The horizon burns. The smell of Hanging Rock is in the air. War is no longer distant.

Stage Directions

● Samuel stands near tree, looking north.

● Eliza sits on bench, hands clasped in prayer.

● Mary paces, whispering rumors.

● Anne sits beside Eliza, holding her arm.

● Thomas wrapped in blanket, staring at glow.

Dialogue & Interaction

Samuel (grim):

That smoke... it's Hanging Rock. Our men fought hard, but the British hold strong.

Eliza (whispering):

Lord, keep them safe. Keep us safe.

Mary (urgent):

I heard Jacob was wounded. They say the fighting was fierce.

Anne (fearful):

Is the war coming here? Will the Redcoats burn our home?

Thomas (holding blanket):
 Why so much smoke, Papa? Is the forest burning?
Samuel (kneels to Thomas):
 Not the forest, son. It's battle smoke. Men fighting for freedom.
Eliza (turns to Mary):
 Who told you about Jacob?
Mary (worried – excited – while sharing the news):
 A rider passed through. He said some never made it back.
Anne (whispers):
 What if Papa has to fight too?
Samuel (looks away, silent for a moment).
 (Lights dim as narrator steps forward.)
Narrator:
 Tonight, the smoke of war is heavy in the sky—and fear paints every heart.

● **Scene 4 – Gates Marches South**
Setting: Main room, candlelight.
Props: Map on table, candle, tin cups.
Mood: Hope mixed with dread.
Narrator:
 Early August. An army marches south, carrying hope—and risk.

Stage Directions

- Samuel studies map at table.
- Eliza stands behind him, arms folded.
- Mary leans over map, curious.
- Anne sits near hearth, silent.
- Thomas marches with stick, humming.

Dialogue & Interaction

Samuel (update with warning tone):
 Gates is bringing an army down from the North. They are saying that they look worn already.
Eliza (facing Samuel, speaking with concern):
 If they fight here, what will become of us?
Mary (adult comment but childlike question):
 They say the militia has no powder. How can they win like that?
Anne (concerned about her home and others around her):
 Why do they choose places where people live?
Thomas (marching like a toy soldier):
 Look, Papa! I'm a soldier!

Scene 5 Background



Gates Marches South – Early August 1780

Narrative Scene:

- Samuel describes Gates' troops marching toward Camden.
- Mary shares concerns about exhausted militia.
- Eliza fears a battle near their home.
- Anne asks why leaders choose battlefields near where people live.
- Thomas pretends to march like a soldier.



Samuel (smiles faintly at Thomas, then turns serious):
 War isn't a game, son.
Eliza (whispers):

Eliza (holding the family together):
 I've set aside bread and broth.
Mary (wanting to be an adult but concerned like a child):

Thomas (upset):
 I can't sleep. The guns sound like thunder.
Samuel (kneels by Thomas):
 Close your eyes, son. Think of quiet fields.

Tonight, silence is heavy—but tomorrow, the earth will shake.

- **Scene 6 – Battle of Camden**

Setting: Main room, chaos.

Props: Bandages, basin of water, chair for wounded soldier.

Mood: Chaos, grief, resilience.

Narrator:

August 16. The ground shakes. Gates' army collapses. Survival becomes the only victory.

Stage Directions

- Samuel bursts in, mud-streaked.
- Eliza kneels by wounded soldier.
- Mary binds wounds.

- Anne clings to Eliza.
- Thomas hides behind hearth.

Dialogue & Interaction

Samuel (hysterical but measured update):

It's over. Gates' men are running.

Eliza (motherly):

So many gone... so many hurt.

Mary (stern):

Hold still—I need to bind the wound.

Anne (concerned high-pitched voice):

Will they come here?

Thomas (childlike scream):

When will this be over? Please – just make it stop!

Samuel (grips Eliza's shoulder):

We'll endure. We must.

(Lights dim as narrator steps forward.)

Narrator:

The Battle of Camden is a disaster—but for this family, survival is victory.

- **Final Narrator Wrap-Up**

Narrator: (Center stage, spotlight)

Fear was constant—raids, shortages, and rumors shaped every choice. Homes became shelters and hospitals. Children grew up under the shadow of war. Yet, despite defeat, local fighters struck back. Francis Marion's swift raids crippled British supply lines. Thomas Sumter rebuilt shattered militia bands. Families risked everything to quietly share important news with Patriot soldiers and to hide Patriot scouts who needed help. The year ended in hardship, but hope endured. Sumter rallied his men. Marion harassed British columns. Nathanael Greene took command, turning the tide. The sacrifices of families, townspeople, and leaders paved the way for ultimate victory.

(Lights fade to black.)

How to submit items to *The Palmetto Patriot*

Here are some pointers.

Keep articles as short as possible while still telling the story. Send articles in Microsoft Word format to Tom.Hanson@HansonCommunications.org

Send digital photographs as attachments and not embedded into the Word document.

Make sure you images are high resolution, at least 200 DPI, and that no time or date stamps appear in the images.

Limit the number of photographs to those you would like most to appear in the publication.

In group shots, have participants drop their hands to their sides to avoid fig leaf poses.

When taking photos at meetings, get as close to the speaker as possible, and avoid shooting the backs of audience heads.

From Eric Barnhill, Gen. Andrew Pickens Chapter: Fill the frame with the subject, unless you are trying to capture a large area (monument, battlefield). Better to get head shots than feet shots. Choose your background carefully. Often it just takes a minute to look around and find a more appropriate background. Watch your lighting. Better to have subjects face the lights (sun for outdoor shots) and be careful of indoor lights, your camera may set the exposure for lights if they are in the shots. Articles are always more interesting when pictures accompany them. Take lots of digital pictures and choose the ones that best capture the subject. Check your spelling, spell check sometimes makes words you don't want.

Rev. Dr. Theodore ‘Ted’ Roosevelt Morton, Jr., 1931-2026

In any organization with local, state, and national components, it is not unusual for the cream to rise to the top.

Such was the case with Compatriot Ted Morton. For many years, he served as Chaplain of the South Carolina Society of the Sons of the American Revolution. At quarterly Board of Governors meetings, he delivered the invocation—always prefaced by a brief, one-minute sermon. In those 60 seconds, he could impart more spiritual meaning to the day’s patriotic deliberations than many could convey in an hour.

His passing leaves a void in our Society that will be difficult to fill. We are all better for having known him and for having called him our Compatriot. Gary Blanpied, Ph.D., Senior Vice President.

Rev. Dr. Theodore “Ted” Roosevelt Morton, Jr., 94, retired member of the South Carolina Conference of The United Methodist Church, died Friday, February 6, 2026, at his home, after a long, meaningful and productive life.


Dr. Morton was born June 18, 1931, in Wilson, North Carolina, to Theodore R. Morton, Sr., and Katherine M. Morton. He was educated in the public schools of North and South Carolina, and graduated from McClenaghan High School, Florence, South Carolina, in the Class of 1949. He was a graduate of Wofford College, Spartanburg, South Carolina, Class of 1953, and The Divinity School of Duke University, Durham, North Carolina, Class of 1956.

In the Winter of 1969, he completed specialized training at the University of Michigan, Ann Arbor, Michigan, to prepare for service in Retirement Housing Management. Wofford College conferred the Honorary Doctor of Divinity degree in 1981 recognizing his service to South Carolina Methodism.

Dr. Morton married Henrietta Mayo Rosson on August 20, 1954, in Liberty Universalist Church, at Feasterville, in Fairfield County, South Carolina, near her home at Shelton. They returned to Liberty Church frequently as they served offices in the Coleman-Feaster-Mobley Family Association. Three children blessed their marriage: Kent, Teddi and Bill. He was a Ministerial Member of the South Carolina Conference of the United Methodist Church, Elder, 1956, and held several offices in his more than 70 years of conference membership. He attended Main Street United Methodist Church, Greenwood, and the Bible Sunday School Class.

Having graduated from Wofford College with a Commission in the US Army

via College ROTC, in September 1956, Dr. Morton began active duty as an Army Chaplain to fulfill his ROTC obligation for service. His first duty assignment was Fort Benning, Georgia, with the 15th Infantry Regiment, Third Infantry Division. At the end of 1957, the third division began a unit-by-unit move to West Germany to replace the 10th Infantry (the Mountain Division). The Morton family — Ted, Henrietta and Kent, born in 1957 at Fort Benning, moved to Bamberg in Bavaria, serving there until April 1961. Teddi, born at the US Army Hospital, Nuremburg, joined the family in 1959.

Dr. Morton left active duty when the family returned to the States, and was appointed Associate Minister of Shandon United Methodist Church, Columbia, SC. Bill joined the family in 1963, during the Columbia years. Following three years at Shandon UMC, and four years in Aiken County (serving Bethel UMC Church, Jackson, and Wesley Chapel UMC, Beech Island), he was appointed to begin the development of Greenwood Methodist Home (now “Wesley Commons”); so, in the Summer of 1968, the Morton family moved to Greenwood. He served for 27 years at Greenwood Methodist Home, retiring as President in June 1995. From 1984 until 1986 he served as Secretary of the SC Conference of the United Methodist Church, working with Bishop Edward Tullis and Bishop Roy Clark. He was serving as a Foundation Director at the time of his death for the SC United Methodist Foundation, of which he was a Founding Member

and had at one time served as Chairman of the Board of Directors. Following his active duty service, he served in the

US Army Reserve in the First and Third Brigades (SC and NC) of the 108th Division (Training), retiring in 1991 as a Lieutenant Colonel.

During his years of service in Greenwood, Dr. Morton established the “Meals-on-Wheels” food services program, working from the basement of the Greenwood Methodist Home Nursing Center, utilizing their Food Service Department, to provide hot, healthy meals to seniors in the Greenwood Community. He later led the effort to create the Greenwood County Council on Aging (now Piedmont Agency on Aging) when the late John Nave, then Mayor of Greenwood, made the request. The Council then established the Greenwood Senior Center for seniors in the Greenwood Community and eventually assumed operations of the ongoing “Meals-on-Wheels” food services program.

Dr. Morton also held membership and served in official positions with the SC Association of Not-for-Profit Homes and Services for the Aging, which he helped establish and served for six months as Executive Director; the Greater Carolina Association of Non-Profit Homes; the American Association of Homes and Services for the Aging; the SC Commission on Aging; the Military Officers Association of America (MOAA); The Self Foundation, as a Trustee; the Greenwood Rotary Club, being named a Paul Harris Fellow in 1982; the Greenwood Chamber of Commerce, as a Board Member and Committee Chair; The Greenwood County Chapter of the American Red Cross; the Greenwood United Way; and was a current Patriot of the Star Fort Chapter of the Sons of the American Revolution, having served as a past President, and was the current and longstanding Chapter Chaplain. He was active in various other local civic clubs during the many years of his ministries in South Carolina.

In 2019, South Carolina Governor Henry McMaster awarded Dr. Morton “The Order of The Palmetto,” the State’s highest award for service. In 1976, he was the recipient of the Community Service Award by Rotary International; and was a decorated Army Commendation Medal recipient, for meritorious service.

Dr. Morton is survived by his wife of 71 years, Henrietta Rosson Morton; his three children, Kenneth (Kent) Patterson Morton; Theodora (Teddi) Rosson Morton Miles; and William (Bill) Spencer Morton, II., three grandchildren Kristen M. Ander-

son, Megan K. Miles and James Rosson (Ross) Miles, and six great-grandchildren, Ethan Brock Anderson, Edward Blake Anderson, Eli Bryce Anderson, Cora Stassaline (Stassi) Miles, Michelle Jade (MJ) Miles and William (Liam) James Miles. His sister and only sibling, Ann Morton Pitt (Mrs. W. W. Pitt, Jr.), of Merritt Island, Florida, also survives him.

Dr. Morton credits much of his accomplishments in life on the outstanding education he received and was proud to be born into a family that exemplified the

value of volunteerism. He was most proud to have developed a retirement community in Greenwood which achieved such great success.

Dr. Morton was buried at Elmwood Cemetery, Columbia.

George Washington

“The character of Washington,” says Washington Irving, “may want some of those poetical elements which dazzle and delight the multitude, but it possessed fewer inequalities and a rarer union of virtue than perhaps ever fell to the lot of one man.... It seems as if Providence had endowed him in a pre-eminent degree with the qualities requisite to fit him for the high destiny he was called upon to fulfil—to conduct a momentous revolution which was to form an era in the history of the world, and to inaugurate a new and untried government, which, to use his own words, was to lay the foundation ‘for the enjoyment of much purer civil liberty and greater public happiness than have hitherto been the portion of mankind.’”

“This bright assemblage of virtues strikes us with less astonishment when we add that their possessor was, both in faith and practice, a Christian....

Washington received the rudiments and foundation of his great life and character in a Christian household and trainings. He was blessed with pious parents, who were members of the Episcopal Church, under the ecclesiastical establishment of the Church of England, which was then almost the only denomination of Christians known in the colony of Virginia. He was consecrated to God in faith and prayer, and in the rite of baptism according to the creed of that Church. The record of this religious act is found in the family Bible of his parents.

His father not only instructed his son in the obligations of morality, but that “the fear of the Lord is the beginning of wisdom.” Piety, as the source of all goodness and the elementary basis of all true greatness, was the cherished aim and the chief effort of Washington’s father; and from him and his mother he received the inestimable blessing of a sound religious education; but; in common with most illustrious men who have adorned our race, Washington points, as the chief earthly source of his successes and greatness, to home influence directed by a Christian mother.

Battle of Great Cane Brake 250th Anniversary Monument Prayer of Dedication December 6, 2025

South Carolina Society Sons of the American Revolution

Today, we meet on a small but significant battlefield of the American war for its independence to dedicate a monument to those who were victorious in battle. Our posterity will have the opportunity to continue to pay respect to our patriot heroes with the placement of this monument.

"It is altogether fitting and proper that we should do this" AL. We have two tasks before us this day: to preserve the history of the struggle for our nation's liberty, and to tell the stories of the heroes who made it happen.

This ground was made hallowed by those who committed their lives to the cause of independence from a tyrannical monarchy. Fifteen hundred men fought here for a cause that was right in their own eyes; up to six men fighting for the king lost their lives in the surprise attack, and one patriot was wounded. This monument today is for all Americans, whose differences of yesterday allow us to be united today.

King David said in a prayer: "blessed be the Lord, my rock, who trains my hands for war and my fingers for battle. My lovingkindness and my fortress, my stronghold and my delivered, my shield and He in whom I take refuge."

You see, God gifts certain men to be effective soldiers.

The bravery of the men earning this victory deserves every accolade we can give. This victory greatly limited loyalist and tory activity in the backcountry for the next 4 years. The Southern patriot militia now had one enemy - local native tribes. Having to focus on just one primary enemy could have been the difference in preserving the will and fortitude of all Carolinians to resist the horrors of the British and Tories later in the war. In a letter to his wife, General Nathaniel Greene wrote of the war in South Carolina: "you can have no idea of the distress and misery that prevails in this quarter. Hundreds of families...are reduced to beggary and want...Human misery has become a subject for sport and ridicule." A hurricane striking the coast had less fury than neighbors attacking neighbors. JHC

God uses geography and weather as often as He uses man in the execution of His will. This land was selected as a loyalist camp for the potential to offer security to alert for an approaching enemy. The snapping of hollow reeds of cane brake would sound alarm for invaders. Yet, it was maybe the sound of campfires of crackling cane brake which gave away the loyalist position here. Could God have used the cane brake to compromise Loyalist safety instead of providing security? Could it have been God's Providence that Col. Thomson's patriot militia was able to quietly surround Captain Cunningham's cane brake camp before the battle commenced? Could it have been God's will for Thomson to decide to attack on Dec. 22 which he could not have known to have avoided heavy snow a day later? Was it God's Providence that the loyalist commander was resting in such a manner that he was undressed and unprepared for the surprise attack? Only the Almighty God knows. We have faith that His hand guided all of the day's events on December, 22, 1775 no different than He guided the armies of Joshua, Gideon, and David.

We know that God uses war as a means to grow our faith. The writer of Hebrews says "for time will fail me if I tell of Gideon, Barak, Samson, Jephthah, of David and Samuel and the prophets who by faith conquered kingdoms, performed acts of righteousness, obtained promises, shut the mouths of lions, quenched the power of fire, escaped the edge of the sword, from weakness were made strong, became mighty in war, and put foreign armies to flight." HEB History through the lens of faith shines bright God's blessings on this nation.

God's hand of Providence allowed George Washington's army to escape disaster in New York under the cover of fog; God's hand weakened Burgoyne's army by 1,000 men on its way to Saratoga by sending men to fight militia at Bennington. God's hand of Providence allowed the dreadful winter of Valley Forge to become a training ground for Washington's army. God's hand prevented the British Army from escaping Yorktown by water when the weather prevented boats from escorting the army across the York River. It was God's hand that, for four years after Cane Brake, General Washington did not have to divide his army to defend South Carolina. God's hand allowed a timely messenger from the losses at Fishing Creek and Camden to reach the militia at Musgrove Mill in time to prevent a patriot counter-charge and allow for their escape from approaching danger. I believe we can also see God's hand at work here at Cane Brake.

King David offered prayer of praise for deliverance in battle. "For who is God, but the LORD? And who is a rock, except our God, the God who girds me with strength and makes my way blameless? He makes my feet like hinds' feet, and sets me upon my high places. He trains my hands for battle so that my arms can bend a bow of bronze. You have also given me the shield of Your salvation, and Your right hand upholds me; and Your gentleness makes me great. You enlarge my steps under me and my feet have not slipped. I pursued my enemies and overtook them, and I did

not turn back until they were consumed. I shattered them, so that they were not able to rise; they fell under my feet. For You have girded me with strength for battle; You have subdued under me those who rose up against me. You have also made my enemies turn their backs to me. And I destroyed those who hated me....I beat them fine as the dust before the wind; I emptied them out as the mire of the streets. You have delivered me..." PS2

Father God, I ask today that you give us the strength to face today's challenges just as you gave our ancestors the strength to face the enemies of liberty. We thank you for providing us the resources

to dedicate this monument in honor of our forefathers. We pray that You will allow future generations to keep alive the memory of this struggle for liberty so that our nation's liberty is never surrendered. Amen.



In recognition of these outstanding efforts, the **South Carolina Society** was awarded the **Syracuse Award**, presented to the state society that charters the highest number of new chapters in the preceding year.

Job well done, gentlemen.

Thomas Jefferson Bond, Jr. Memorial Photographic Award

This award was created and funded by Wilma 'Sunni' M. Bond as a memorial to Thomas J. Bond, Jr. (1936-1997). The annual award shall recognize and reward the compatriot whose photographic entry is selected as the most representative of patriotism. The money given to the NSSAR by Mrs. Bond is to be invested in such a manner as to yield at least \$1,000 annually in earnings, earnings up to \$1,000 to be presented to the winner. If the earnings in any year are less than \$1,000, the award shall be given in increments of \$100 (i.e., \$900). Any excess earnings shall be added to the principal. An SAR certificate, appropriately embossed, shall accompany the award. Incidental administrative expenses, i.e., the cost of the certificate, may be deducted from earnings prior to any excess reverting to principal. Should the name of this award ever be changed by NSSAR, the original \$20,000 donation shall revert to the Bond Memorial Trust as of the date of any such name change.

Entries are to be no greater than 8 1/2" x 11" in size, unmounted and unframed, and may be in color or black-and-white. Only one entry per compatriot will be accepted. Entries are to be sent to NSSAR Headquarters for judging during the Spring Leadership Meeting. All photos to be considered must be received by the Executive Director no later than February 15 of each calendar year.

Judges shall be the SAR Magazine Editor, Historian General and Chairman (Chairmen) of the Historic Sites and Celebrations Committee(s). If the latter is unavailable or if that committee is ever absorbed by some other entity, the other two shall select the individual(s) to serve as the third judge with preference being given to the chair of a committee devoted to patriotism. Judges will reach their decision in whatever manner they deem appropriate, so long as only one picture is selected as the winner. Announcement of the winner and presentation of the check and certificate will occur at Recognition Night during the Annual Congress each year. The SAR Magazine Editor is requested to run a reproduction of the winning photo each year in the issue of the SAR Magazine in which Congress events are reported.

All entries become the property of the National Society Sons of the American Revolution and will not be returned. The award was first presented in 1998.

Mrs. Bond donated an additional sum to NSSAR that will bring the annual award to \$3,000, beginning in 2026 (The additional donation has to have a year to earn interest before the actual award is increased).

From Rick Morris, Piedmont Vice President: Mrs. Sunni Bond is a member of a local DAR Chapter and very supportive of our Cambridge Chapter. Thomas Bond was Registrar General, and at the time of his death, preparing to run for Secretary General. The award was first announced at the 1997 NSSAR Congress, just a few months after Tom's untimely death. Sunni Bond had the privilege several times of presenting the check and certificate in person.

Annual Commemorations and Events

The Parker's Guide to the Revolutionary War in South Carolina, current edition, identifies the location of more than 580 actions that took place in our state. Every Chapter is asked to host or co-host at least one annual commemoration associated with one of these actions.

Commemorations are ranked as a "National Event" (top priority), "State Event" (secondary priority), or "Chapter Event" (third priority). The State and Chapters may not schedule events in conflict with National events, and Chapters may not host events in conflict with a State event. Chapters within the same region are discouraged from hosting events that conflict with each other. The interest is in having all compatriots free to attend every event. If there is a conflict in dates, the State President or his representative and the State Color Guard attend events based on their priority (1st National, 2nd State, 3rd Chapter).

Note that the Historic Sites Committee has oversight and authority over all National events that take place in South Carolina according to State Bylaws. Host Chapters are under the cognizance of this State Committee regarding how these events are commemorated.


